The freight forwarder and, where applicable, its subcontractors hereby declare their willingness to comply with the following conditions for the transport of foodstuffs and, if necessary, to provide the respective evidence upon request.

General Conditions

- The used vehicles are suitable for transporting food.
- The vehicles must be in good technical condition and comply with the legal requirements of the destination country or the countries that are being passed.
- The vehicles must be dry and clean.
- The loading compartment must be free from mold, dust, dirt and foreign odors.
- Vehicles are free of pests/ vermins. There should be no trace of pest activity and pest presence.
- Before loading the condition of the transport vehicles is checked and if necessary measures are taken.
- Procedures for the prevention of cross-contamination have been introduced (separation of food / non-food/ different categories of goods).
- There are adequate hygiene requirements for all transport vehicles and tools for loading and unloading. The measures are documented.
- Without exception goods may be taken over on faultless Euro exchange pallets. Only impeccable boxes may be taken over. No takeover of damaged goods (for example, dented/ bulging/ leaky/ rusty goods)
- The driver is responsible for the traffic-proof stowage of the cargo. This means that the
 cargo is to be stored and secured in such a way that it does not slip, fall over or roll
 back, even during emergency braking or a sudden evasive maneuver.

Temperature controlled Transports

- For all transport containers, vehicles and where applicable, cooling units a defined maintenance and cleaning plan is specified and implemented accordingly; cleanliness and functionality are logged and archived
- The refridgerated vehicles keep the temperature of the products within the permissible tolerance also at full load.
- For refrigderated transports the temperature needs to be logged (thermograph) and to be presented upon request. Core temperatures are recorded at least three times during loading/ transport.
- Only goods with a core temperature of at least minus 18° C (1° C tolerance) are to be taken over

- Temperature measurements and subsequent acceptance of the goods must be documented. Deviations must be reported immediately and the loading must be stopped.
- Cooling units need to run with an output of minus 20° C.
- For tank wagon transports the previously transported food needs to be disclosed.
- Before loading, a cleaning certificate must be presented by accredited institutions. The cleaning includes both the filling and discharge nozzles and the connecting hoses.

Food Defense

- The truck drivers are trained according to the "Food Defense" regulations, understand and implement them.
- During resting breaks the trucks must be parked in secure places.
- Loading units are locked during breaks. At all times the vehicle and the cargo are protected against access by strangers and thus manipulation is excluded
- Transports from third party countries as well as within the EU are sealed. Seal numbers are to be documented in the shipping documents
